## WHAT IS THE E2-VISA?

The E2 visa is a non-immigrant visa for investors, entrepreneurs, and individuals seeking to run a business in the United States. With an E2 visa, you can either start a new U.S. business or invest in an existing U.S. business and operate it independently.

To qualify for an E2 visa, you must invest a significant amount of capital—approximately \$100,000—into a U.S. business and actively develop it. You can either start a new business or invest in an existing one.

# BENEFITS AND REQUIREMENTS OF THE E2 VISA:

- There is no specific educational background requirement, no age limit, and no test required.
- With an E2 visa, you can start and operate a business in the United States, or invest in an existing business.
- Your spouse and children under 21 can accompany you.  
**Note: If your children are over 21, they may join you as partners in the business. However, the investment amount will be increased to \$200,000 to include you and your child as partner in the business plan.**
- The visa is initially valid for 2 years, with the possibility of a 5-year extension.
- Your spouse can obtain work authorization in the United States.
- Your children are entitled to free education until high school.
- Unlike other non-immigrant visas, you do not need to maintain a foreign residence to qualify for an E2 visa.

## PROCESS:

- To begin, we will sign an agreement with you.
- First, your company will be registered in the U.S, an IRS Tax Identification Number will be obtained, and your company account will be opened. Then, you will make the required investment in your account.
- The overall processing time is approximately 5 to 6 months.
- Our business consultant will make business plan for you according to your choice.
- Our chartered accountant will manage your bank account and tax criteria's etc.



## OUR TEAM:

Our lawyer, business consultant, and chartered accountant in the U.S. will manage all aspects of your application:

- Lawyer: Our lawyer will oversee and update you on the entire visa application process.
- Business Consultant: Our business consultant will prepare a business plan tailored to your preferences.
- Chartered Accountant: Our chartered accountant will handle your bank account and tax-related matters.

## BUDGET:

## VISA PROCESSING AND EMBASSY DETAILS:

- The main applicant will need to attend an interview at the U.S. embassy. Prior to the interview, it is essential to read and understand the business plan thoroughly to explain it to the visa officer and address any other criteria.
- We will schedule an appointment with the U.S. consulate in Karachi (preferably), which typically takes 2 to 3 months.

**Note: The chances of visa rejection are very low. However, visa refusal may occur for two reasons: failure to adequately explain the business plan or insufficient investment. If a visa is not approved on the spot, you will be given two opportunities to rectify any short coming.**
